The guarantor must complete and sign the "Guarantors Declaration" form. The photo must be provided by the individual and taken within the last 6 months clear enough for easy identification. The photograph must show the head and shoulders and **must not** include a hat, headband, sunglasses, or similar apparel. **Do not cut** the photograph as we will cut it to the appropriate size upon arrival.
